

NOTE TO AUTHORS

The *Revue de l'OFCE* is a peer-reviewed journal registered with the CNRS. It encourages the submission articles advance thinking in economics and sociology, using a variety of approaches to promote public and scientific debate.

Articles submitted to the *Revue de l'OFCE* must be unpublished and must not be submitted simultaneously to another journal.

Procedure

The texts received are the subject of one or two written reports, sent to the authors, respecting the anonymity of the parties involved. On the basis of these reports, the Editorial Board will decide either i) to accept, ii) to reject or iii) to accept subject to modifications taking into account the remarks and comments of the referees. This decision is communicated within a maximum of four months of receipt of the manuscript. Once accepted, the texts may be edited consultation with the author.

Format

Articles

They must be submitted in Word, as must the tables. Graphics should be sent in Excel and images (in .eps or .pdf if possible) should be of good quality.

Articles must not exceed 75,000 characters (including spaces), including tables, graphs, notes, bibliography and appendices. A page of text is approximately 2,500 characters (including spaces) for a page size of 110 x 185 mm. A graph is approximately 1,000 characters (including spaces). The following should appear at the beginning of the article

- The title (120 characters including spaces maximum) ;
- The name(s) of the author(s) with affiliation ;
- A summary in French (maximum 1,200 characters including spaces) ;
- Four or five key words.

Authors must also provide :

- A summary in English of no more than 150 words, including the title and name(s) of the author(s) ;
- Four to five *Keywords* ;
- The classification of the article according to the *Journal of Economic Literature* nomenclature.

Intertitles

Three levels may be used (two levels are recommended) ; they must be numbered without the introduction. The first level should be numbered 1, 2, etc. ; the second level 1.1, 1.2, etc. Avoid using several

sub-headings immediately after each other (intersperse them with a few lines of writing if possible).

Footnotes

They must be numbered consecutively. They must be short.

Tables and charts

Tables are numbered consecutively and must be referred to in the text. The same rule applies to graphics. All tables and graphs should have a short title. Units must be clearly indicated, distinguishing any double scales. Full sources must be provided : organisation and, if applicable, the full title of the publication and date.

Boxes

They should be numbered (avoid boxes that are more than two pages long, i.e. more than 5,000 characters) and the tables and graphs in them should be numbered with those in the text.

Mathematical formulae

They must be in MathType or Word's equation editor, or in eps.

Symbols in the text must remain in text.

Articles prepared in Latex format will be converted into Word at the OFCE.

References

They are referred to in the text by the author's name and the date of publication, in brackets: x (date) or (x, 2005; x and y, 2006; x *et al.*, 2000). They are grouped at the end of the article in alphabetical order by author. They include the author's surname, first name, date of publication, title of the article, name and number of the publication, publisher and place of publication.

The deadline for electronic distribution of the article is under the responsibility of the OFCE: the article is put online immediately on the OFCE website after proofreading validated by the author, the editor-in-chief of OFCE publications and the President of the OFCE, and is then available on CAIRN a few weeks later.
